Retirement of Non-Executive Director

On 20 December 2023, Elanor Investors Group (ASX: ENN) ("ENN" or "Group") announced the intention of Mr Nigel Ampherlaw to retire, later in 2024, from his position as Independent Non-Executive Director, and Chair of the Audit and Risk Committee.

The Group advises that Mr Ampherlaw has retired as an Independent Non-Executive Director of the Group and Elanor Funds Management Limited (**EFML**), the Responsible Entity of Elanor Commercial Property Fund (ASX: ECF), effective 23 September 2024. As previously announced, Ms Kathy Ostin, who joined as an Independent Non-Executive Director in January 2024 and who has been a member of the Audit and Risk Committee since then, will succeed Mr Ampherlaw as Chair of the Audit and Risk Committee.
